Terms & Conditions:

- The Prize Money Claim Form must be signed by the individual to whom the prize money is to be sent.
- Only original or scanned copies of the Prize Money Claim Form sent via post or email will be accepted. Copies sent by any other means will not be accepted.
- Bicton Arena cannot be held responsible for Prize Money Claim Forms that are not received. Received Prize Money Claim Forms will be acknowledged by email only to the email address provided.
- A single payment will be made to either the Rider at the Bicton Arena Horse Trials or the BE Registered Owner of the placed Horse in question. In the case of multiple Horse Owners payment will be made to only one of the BS Registered Owners of the Horse in question.
- Electronic transfers will be made free of charge to UK bank accounts.
- Non-UK bank transfers will incur electronic banking charges as well as possibly currency exchange costs which will be deducted from the prize money sent.
- Electronic transfers cannot be retrieved once they have been sent so bank details must be correct.
- Bicton Arena cannot be held responsible for incorrect bank details being provided. Funds sent to the incorrect bank account may not be retrievable.
- The Payment reference will be Bicton BS.
- All requests for Prize Money payment must be received by the Bicton Arena team no later than **17:00** on **Friday 9th October 2020**

Any unclaimed prize money will be donated to the Devon Air Ambulance Trust www.daat.org

- UK Tax Residents – No deductions in respect of any Income Tax and National Insurance contributions arising from or payable in connection with this payment will have been made by Bicton Arena on the recipient's behalf. Any payments of Income Tax or National Insurance Contributions are solely the responsibility of the recipient of this payment.
- Non-UK Tax residents – We may need to get in touch with you to obtain additional bank account information to execute payment. UK Withholding Tax may be applicable at the time of payment and this will then need to be deducted from the Prize Money payment. A Tax Deduction Certificate will be issued should UK Withholding Tax apply.
